- 3. An amount of Rs. 10,000/- per month has been estimated on their TA/DA which would be paid on actual basis upon furnishing the original bills/ tickets at the norms fixed by NSKFDC for its Executives at E-0 level.
- 4. The selected candidate has to be stationed in different parts if the State for field duty.
